STRUKTOL® WB 42 is especially suited for applications in extruded compounds, including continuous vulcanization, but also offers advantages with transfer-moulding and injection-moulding.

STRUKTOL® WB 42 does not affect peroxide cure. STRUKTOL® WB 42 shows no tendency to blooming even at higher dosages.

2 - 5 phr

Compounds with high filler concentrations, especially mineral fillers, may require higher dosages (up to 7 phr).
